## Guidance for Presenters in Parallel Sessions

Please see the guidance for presenters document that is available on the LSA 2025 website ([please click here](#)). A number of reminders are however also provided below in terms of the organisation and running of parallel sessions.

### Presentations

- Presenters will be allocated a 20-minute timeslot (15 minutes to present, followed immediately by 5 minutes for questions).
- Presentations will take place in the same order that they are printed in the conference programme above.
- York St John University operates Microsoft Windows machines in teaching spaces. PowerPoint is therefore recommended for the purpose of presentation slides.
- Each room/space will be equipped with a desktop computer, keyboard, mouse, presentation screen and projector.
- Presentations can either be emailed to conference organisers in advance of the conference ([Isa2025@yorks.ac.uk](mailto:Isa2025@yorks.ac.uk)) by the previously advertised deadline: close of play on 29 June 2025.
